SHOW RULES:

1. This show is restricted to Civil War, World Wars I & II thru Vietnam or earlier period memorabilia, relics, books, paper goods, photographs and weapons, Veterans items, and related art prints. Material deemed objectionable by the NVRHA Show Committee must be removed from exhibitors' tables. If you have any questions about what may be sold, please check with the Show Chairman prior to the show and before ordering tables.

Antique guns are commonly sold at our show. Sales of modern guns manufactured after 1892 are strictly PROHIBITED. Modern guns are of great interest but MUST clearly be marked DISPLAY ONLY! Exhibitors are also reminded that they are responsible for their own table security.

- 2 ABSOLUTELY NO LOADED EXPLOSIVE ORDNANCE WILL BE PERMITTED ON THE PREMISES OR IN THE SHOW. VIOLATORS WILL BE IMMEDIATELY REMOVED AND BARRED FROM THE SHOW.
- 3. Metal detecting equipment and related material, and quality reproduction Civil War, WWI, WWII, Vietnam and other military type material may be sold. Reproductions should be clearly marked.
- 4. Souvenir items such as bumper stickers, teddy bears, mugs, etc., <u>cannot</u> be offered for sale.
- 5. Exhibitors must provide covers for their tables. Tables are 6' by 30".
- 6. Exhibitors MUST wear their own exhibitor passes at all times during the Show. The loaning of exhibitor badges to individuals not named on the badge(s) will result in the loss of the badge to the proper badge holder.
- 7. There will be no selling or trading from EXHIBIT ONLY tables.
- 8. Exhibitors will be limited to TWO passes for the first table and ONE additional pass for each additional table. No blank exhibitor passes will be issued. All sale tables and exhibits MUST REMAIN INTACT AND UNCOVERED until the close of the Show at 6 PM Friday and 4 PM on Saturday. If you close your table early on Friday evening and/or you leave early on Saturday afternoon, you may not be invited back for the following year's show. Tables must be cleared between 4-6 PM on Saturday

- 9. Disputes between exhibitors, dealers, and/or members of the public are to be kept outside the Eagles Lodge building. If you are involved in a dispute that disrupts the Show, you may be asked to leave and you may not be invited back for future shows.
- 10. Dealers and exhibitors are responsible for maintaining security over their own tables during the Show. Some NVRHA members will wear security arm bands during the show and be able to assist Exhibitors as needed. The Fredericksburg Fraternal Order of Eagles (FOE) and the Northern Virginia Relic Hunters Association do not assume any responsibility for any loss, theft, or injury that occurs during the Show. **Please watch your tables!!** The FOE has a state-of-the-art security system that is activated during non-show hours.

<u>TABLE CONFIRMATION</u>: Table confirmation will be sent to exhibitors a few days after table order has been received. If you have not received your table confirmation within 20 days after mailing your application, contact the Show Chairman at 703-855-2376 (voice or text.) If you entered an email address with your application it will be used to confirm your reservation and payment. <u>EXHIBITOR BADGES</u>: Badges will be distributed at the exhibitor entrance prior to show opening and should be picked up on entry. Your badges will be in a manila envelope under the company or applicant name that appears on the table application form.

<u>TABLE REQUESTS</u>: Requests for specific table assignments, such as being located near a particular exhibitor, may be made on the table application but cannot be guaranteed. We will try our best to accommodate you. Early requests are encouraged and can more easily be accommodated.
